# 1. EXECUTIVE SUMMARY

#### **Project Description:**

Work under this contract consists of improving the existing streetscape and safety for pedestrians and cyclists. The project plans to mill and overlay the pavement surface, reconstruct sidewalks as needed, and install bulb-outs and bus pads, crosswalks, pavement marking and wheelchair ramps. Streetlights, traffic signals and drainage structures will be upgraded. Other design elements considered for the project are LID elements and intersection improvements. The project will upgrade the bike facilities from bike lanes to protected bike lanes, add more pedestrian crossings, and ensure the street complies with the Americans with Disabilities Act (ADA).

This project is 83% Federally Funded and 17% District-Funded. DDOT selected Anchor construction corporation. as the contractor and awarded the \$15,995,763.50 contract on February 17, 2021. DDOT issued notice to proceed with contract work to Anchor construction corporation with work to begin on xx/xx/xxxx and a substantial completion date of xx/xx/xxxx.

Jacobs is providing Construction Management and Inspection services. DDOT issued a task order to Jacobs on 02/12/2021 that will expire on 10/15/2022.

# 2. STATUS OF CONSTRUCTION / PROGRESS SUMMARY

Work this week was performed during the day on date, March 1, 2021 thru date March 5, 2021. Work included the CM Agent reviewing the plans and performing quantity takeoffs, amending documents at the direction of DDOT, setting up and running a coordination meeting between DDOT, Anchor, Jacobs, and Washington Gas, coordinating with the Eliot-Hine Project, producing meeting minutes, scheduling the Pre-Construction meeting, facilitating the operation of the C St NE website, updating procedures, and answering various DDOT queries.

  occurring in the form of house connections that were transverse to the roadway. Miller Pipeline was
  performing this work and the intent is to progress the work against the flow of traffic (eastbound). The
  onsite foreman was Corey Lewis.

- During site visit inspectors noted that Washington Gas crew was working on C St, NE inbound and outbound between Station 97+00 to 117+00, work zone #2, #4 and #5.
