1. EXECUTIVE SUMMARY

Project Description:

Work under this contract consists of improving the existing streetscape and safety for pedestrians and cyclists. The project plans to mill and overlay the pavement surface, reconstruct sidewalks as needed, and install bulb-outs and bus pads, crosswalks, pavement marking and wheelchair ramps. Streetlights, traffic signals and drainage structures will be upgraded. Other design elements considered for the project are LID elements and intersection improvements. The project will upgrade the bike facilities from bike lanes to protected bike lanes, add more pedestrian crossings, and ensure the street complies with the Americans with Disabilities Act (ADA).

This project is 83% Federally Funded and 17% District-Funded. DDOT selected Anchor construction corporation. as the contractor and awarded the \$15,995,763.50 contract on February 17, 2021. DDOT issued notice to proceed with contract work to Anchor construction corporation with work to begin on xx/xx/xxxx and a substantial completion date of xx/xx/xxxx.

Jacobs is providing Construction Management and Inspection services. DDOT issued a task order to Jacobs on 02/12/2021 that will expire on 10/15/2022.

2. STATUS OF CONSTRUCTION / PROGRESS SUMMARY

Work this week was performed during the day on date, March 8, 2021 thru date March 12, 2021. Work included the CM Agent Team organizing, chairing, and participating in several meetings with DDOT, the Designer (Volkert), Anchor Construction, and Washington Gas, producing and revising meeting minutes, reviewing the Safe Accommodation Law and how it applies to the C St NE design, providing a list of plan quantity discrepancies and requested clarifications to Volkert, reviewing and commenting on the Washington Gas provided schedule, reviewing the current MOT phasing in conjunction with the Washington Gas project, updating procedures, and answering various DDOT queries.
